## Agreement

### Terms of this Agreement:

This agreement is entered into between the below signed Dog Owner and The Freckled Paw, LLC (hereinafter "The Freckled Paw"). The Dog Owner wishes to engage the services of The Freckled Paw in the training/counseling sessions for their dog as designated herein below.

The Freckled Paw will take the owner's dog through one or more sessions of training/counseling in an effort to achieve the results sought by the owner, but the Freckled Paw cannot make any guarantees regarding the outcome of any training/counseling program. The owner assumes full responsibility of their pets behavior and well-being before and after the training/counseling sessions.

I understand that attendance of the Freckled Paw Training Class is not without risk to myself, members of my family or guests who may attend, or my dog, because some of the dogs which I (we) will be exposed to may be difficult to control and may be the cause of serious injury even when handled with the utmost care. I voluntarily assume such risk.

I represent and warrant that my pet is physically fit and has no medical condition which would prevent his full participation in any training/counseling session. I agree to bring my dog to the training/counseling sessions clean and free of fleas and parasites. Prior to the first training session, I will provide proof that my dog has received the required vaccinations and I agree to keep these vaccinations current throughout the duration of the training/counseling sessions.

### Waiver and Release of Liability.

The Dog Owner knowingly, voluntarily, and expressly waives any claim or legal action and releases The Freckled Paw, LLC, its owners, officers, instructors, employees, representatives, agents, trainers, volunteers, successors in interest, any referring organization, and any host facility from all liability, property damage, or injuries, fatalities, expenses, damages or losses, to persons, animals, or property arising or resulting from counseling, instruction, handling, training, advice, negligence, action, or inaction occurring during the training/counseling sessions or during the performance of any aspect of this agreement or resulting or arising from the behavior of any other dogs or persons gathering or participating before, during, and after the class of instruction/counseling, or from disease, illness, death, running away, theft, or fire.

The Dog Owner further agrees that his/her dog's behavior is solely the responsibility of the owner of the dog. Should any behavior on your dog's part result in injury or death to persons or damage to property, the Dog Owner agrees to release and hold harmless The Freckled Paw, LLC, its owners, officers, instructors, employees, representatives, agents, trainers, volunteers, successors in interest, any referring organization, or any host facility.

Package payments are due prior to the training session. Payments can be made by credit card, cash, or check made payable to "The Freckled Paw, LLC". Return checks are subject to a \$25.00 fee.

**Missed Sessions.** Payment for the classes is non-refundable and it is the responsibility of the Dog Owner to attend the classes as scheduled. Any missed session not rescheduled within the discussed expiration results in termination of the contract without refund to the dog owner. **48 hours notice is required to cancel any session. Failure to do so does not require refund to the dog owner and may result in forfeiture of the session.**
